- E. All appropriate arrangements and clearances have been obtained from all copyright holders, creators, music licensing organizations, sponsors, representatives and without limitation from above, any and all other persons as being necessary for authorization to transmit this program on cable television and streamed over the Internet and archived for playback on demand. - F. The producer hereby agrees to abide by the NPACT "take down" policy with respect to alleged copyright or license violations from material streamed over the Internet. Upon proper notice to NPACT by a person claiming to represent the license or copyright holder of any material streamed over the Internet, that said material is being used in violation of license or copyright, NPACT shall, as soon as is reasonably possible, "take down", (remove the material from streaming on the Internet), the material in question. Proper notice shall include the following:
 - a. Contact information for the claimant
 - b. The name or description of the song or video that is questioned
 - c. A statement by the claimant that he/she has a good faith belief that the material is not legally used
 - d. A statement, under penalty of perjury, that the claimant is authorized to act for the copyright or license holder.

NPACT will provide the claimant with the name, address, and phone number of the producer upon receipt of the above information. As soon as is reasonably possible NPACT will notify the producer that the material has been "taken down." It is then the responsibility of the producer to verify to NPACT that they do in fact have the legal right to use the material and have resolved the matter with the claimant before NPACT will put the material back up on the streaming feed.

- G. The submitter agrees to defend, indemnify, and hold harmless NPACT, the City and County of Napa, the City of American Canyon, the Town of Yountville, the City of St. Helena, the Napa Valley Unified School District (NVUSD), and the Napa Valley College and all their agents and employees from any liability arising out of the submitter's use of the community access channels. Such liability may include (but not be limited to) copyright infringement, presentation of libelous, defamatory or obscene matter, and violation of any local, state, county or federal laws and regulations. The submitter saves and holds harmless NPACT, the City and County of Napa, the City of American Canyon, the Town of Yountville, the City of St. Helena, NVUSD and the Napa Valley College and all their agents and employees for any and all damages or claims, including all reasonable attorney's fees, arising as a result of the Producer and his/her program and/or use of the channels.
- H. He/She will not represent himself or herself as a representative or agent of NPACT.
- I. He/She has received and read a copy of NPACT's Policies and Procedures and understands and agrees to the terms therein, including the requirement to pay all reasonable attorney's fees for
